The ESSER III funds were described and discussed in two open board meetings. The Acting Superintendent met with the certificated and classified units and discussed this opportunity. The entire Yreka Union School District administrative team, including the Special Education administrators, met to discuss the district needs and how this funding would affect students, families, and the local community. Surveys were used to engage with our community. The surveys were sent to all district staff, parents, and students. 79 staff members, 146 parents, and 199 students responded to our survey. The chairperson of our American Indian Education Parent Committee was contacted and a summary of the activities and projects was described.

We were able to see what items were important for our community members. The feedback from the surveys provided excellent data which we could incorporate in the plan. We even received emails that suggested other ideas. Students indicated that summer school, intervention teachers, and extra aides in SAFE were priorities for addressing learning loss. Students indicated that outdoor tables, bathroom upgrades, and education technology needs were the most important for continuous and safe in-person learning. Staff also saw summer school,

intervention teachers, and additional SAFE aides as priorities for addressing learning loss. Staff indicated that outdoor tables, bathroom upgrades, and outdoor classrooms were important to continuous and safe in-person learning. Parents identified summer school, intervention teachers, and extra SAFE aides as most important to address learning loss. Parents also identified outdoor tables, bathroom upgrades, and education technology as priorities for continuous and safe in-person learning. All of these actions were included in the ESSER III Plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
 - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
